Letter of resignation was received from Mrs. Edward Maguire, member of the Advisory Board - Mrs. Maguire's resignation was accepted with deep regret - she has served as a member of the Board of Directors and the Advisory Board for many years and her work and interest has been of great importance to the Neighborhood House.

Our Golf Day at the Maidstone Club is set for October 7 with October 8th (Thursday) as a rain date. The price of the tickets is \$65.00 which includes the golf and lunch at the Club. All tickets were sold out within three dates of the date being set. Mrs. Hollister will check with the Club on the luncheon arrangements.

Mr. Herrlin reported that the Annual Appeal Letter was supposed to go out on September 1, 1987 but circumstances did not permit that. However. Grant Business has settled its employee problems and the letters will go in the mail today.

Happy news at the meeting was Mrs. Graham's ammouncement that she was pregnant. She forsees no problem in continuing with her work with us. Mrs. Graham reported that Nursery Class started on Monday, September 21, 1987 - with thirty (30) children registered and the same two helpers that worked with her last year.

Mrs. Turi reported that the Women's Service Club has purchase creamers and sugars - salt and pepper shakers - cups and saucers - and some platters. She also reported that the North Main Street Restaurant has a refrigerator that it will give to the Neighborhood House. Mr. Herrlin will stop by and check the box out as to condition, etc.

Mrs. Graham reported that the office and the closet which is adjacent to it has been cleaned out and the excess things stored in those areas had been carted to the dump.
