The Annual Meeting of the East Hampton Visiting Nurse Association was called to order at 4:05 P.M. on July 15, 1967, at the Neighborhood House, with Mrs. George Starke presiding as chairman.

Mrs. Starke suggested that the minutes of the Annual Meeting of July 6, 1966 be dispensed with and that the minutes of the regular meeting of April 22, 1967 be read. On motion of Mrs. Frank Carr, seconded by Mrs. Edward Maguire this was voted and the minutes of the April 22, 1967 meeting were read and approved.

The annual report of the Treasurer was read and accepted. (Copy attached)

Mrs. Selah Lester, Resident Director, reported that the Neighborhood House was still busy - that basketball was being played out of doors instead of in the gymn during the summer months. Also included in her report was the fact that the gymn had been used five nights a week for basketball, and on Saturday mornings, during the winter; that the playground facilities were in constant use by the young children; that Mr. Kiernan was using the building again this summer for his Boys Club - two mornings a week in nice weather - five mornings if the weather was bad. A benefit basketball game had been played at the High School during the winter and the proceeds, in the amount of \$200.00 had been given to the Neighborhood House. On the Nursery School Mrs. Lester reported that those who found it a hardship to pay the small amount collected were not denied having their children attend the sessions; that registration generally starts out with about sixty children and then dwindles down to 40 to 45. With over forty children in attendance it is necessary to hire two helpers since the law requires one adult supervisor for each twenty children; that after the Christmas holidays attendance drops below forty children and then there is only one helper. During the Nursery School year there was a Christmas show for which Mrs. Lester was assisted by Mr. and Mrs. Christian Johnson. This program was very well attened by the parents and relatives of the children. At the end of the Nursery School year an assembly was held with refreshments being served after the assembly.

Wallace Chauncey for the very appropriate decorations on the main table and the lovely flower arrangement in the Main Hall; special thanks also to Mrs. Lester, and to the members of the Service Club who made and served the refreshments for the occasion. Mrs. Johnson concluded her report by noting that there were only about fifty people who attended.

Mrs. Starke, as chairman of the meeting, welcomed the new members of the Advisory Board and expressed the hope that they would find their association with the Neighborhood House both interesting and worthwhile.

There being no further business the Annual Meeting was adjourned at 5:06 P.M.
