NOW, this indenture witnesseth, that the said party of the first part, pursuant to the provisions of said order and in consideration of the sum of TWO HUNDRED DOLLARS (\$200.00), lawful money of the United States, paid by the parties of the second part, does hereby grant and release unto the said parties of the second part, their heirs and assigns forever, ALL THAT CERTAIN PIECE OR PARCEL of vacant land situate in the Town of East Hampton, County of Suffolk and State of New York, bounded and described as follows:

BEGINNING at a point on the southwesterly side of Ten Page Highway, now called Oak View Highway, at the intersection of the boundary line between the premises to be described and premises of Everett Cullum with the southwesterly side of said highway, and running from the point first described southwesterly 168.5 feet along premises of Everett Cullum; running thence northwesterly along other premises of East Hampton Visiting Nurse Association, upon a line which is a continuation of the southwesterly boundary of premises of Everett Cullum with other

That the grantor receives the consideration for this conveyance as a trust fund to be applied first for the purpose of paying the cost of any improvement that has been commenced on the premises and has not been completed at least
